Notes

- Indirect charges that only apply on LPG produced from certain oil and gas fields (such as the Energy Resources Levy or ERL) are not included here.
- Petrol/ethanol blends have an excise of 66.524 cents per litre, only on the petrol portion of the fuel.
- The National Land Transport Fund tax is a duty levied under the Customs and Excise Act 2018. It is also sometimes referred to as Fuel Excise Duty (FED), or Petrol Excise Duty (PED) when applied to petrol. The revenue from this tax goes towards the National Land Transport Fund which is administered by the New Zealand Transport Agency.
- Diesel is not subject to National Land Transport Fund tax. This is because diesel vehicles are subject to road user charges (RUC), which go toward the National Land Transport Fund.
