In order to fulfill the international commitments undertaken by Kazakhstan under the United Nations Framework Convention on Climate Change ratified by the [Decree of the](#) President of the Republic of Kazakhstan of May 4, 1995 No. 2260, the Government of the Republic of Kazakhstan decides:

1. To approve the project proposal of the United Nations Development Program / Global Environment Facility ("UNDP / GEF") "Accelerating the development of wind energy in Kazakhstan" and the proposal to build a pilot 5 MW wind farm in the Dzungar gate area with the participation and financial support of UNDP / GEF.
2. To determine the Ministry of Energy and Mineral Resources of the Republic of Kazakhstan as the coordinator of the construction of a 5 MW pilot wind farm in the area of the Dzungarsky Gate and an authorized representative of the Government of the Republic of Kazakhstan in the work with the Global Environment Facility for Wind Power Development.
3. The Ministry of Energy and Mineral Resources of the Republic of Kazakhstan:
 consider, in cooperation with interested government bodies, a 5-megawatt pilot wind power plant in the Dzungar Gate area (hereinafter referred to as the project) submitted by UNDP / GEF and decide on the implementation of the project;
 to solve the issue of connecting the pilot wind power plant to the existing electric grids and attracting extrabudgetary funds in the amount of 24 (twenty four) million tenge for the development of the Wind Energy Development Program and scientific and technical support of the project as Kazakhstan's contribution to the project;
 to work with the Akimat of Almaty region on the allocation of land for the construction of a pilot wind power plant and provide the necessary organizational and technical assistance in the implementation of the project.
4. This resolution comes into force from the date of signing.
